ORDER CONCERNING PROCEDURES FOR TITLE VI APPROVAL HEARING  
FOR THE PUERTO RICO INFRASTRUCTURE FINANCING AUTHORITY  
AND THE PUERTO RICO CONVENTION CENTER DISTRICT AUTHORITY

In accordance with the scheduling orders entered in the above-captioned Title VI proceedings (the “Title VI Proceedings”), and as stated on the record in the confirmation hearing concerning the *Modified Eighth Amended Plan of Adjustment of the Commonwealth of Puerto Rico, et al.* (the “Title III Plan Confirmation Hearing”), the hearing to consider the applications for approval of the proposed qualifying modifications in the Title VI Proceedings (the “Title VI Hearing”) will begin immediately after the end of closing arguments in the Title III Plan Confirmation Hearing on November 22, 2021, or as soon thereafter as counsel may be heard.

1. The Financial Oversight and Management Board for Puerto Rico (the “Oversight Board”) is directed to file two informative motions in connection with the Title VI Hearing by **3:00 p.m. (Atlantic Standard Time) on November 19, 2021**, on each of the above-captioned dockets. The two required informative motions are the (i) Pretrial Informative Motion and (ii) Title VI Hearing Agenda.

**Pretrial Informative Motion.** The first informative motion the Oversight Board shall file is a Pretrial Informative Motion, substantially in the manner set forth in ¶ 4(a) of the *Second Amended Order Regarding Procedures for Hearing on Confirmation of Plan of Adjustment*. (Docket Entry No. 19012 in Case No. 17-3283, the “Second Amended Confirmation Hearing Procedures Order”). The Oversight Board’s Pretrial Informative Motion shall annex a Party Appearance Sheet, Witness Cover Sheet, and Exhibit Cover Sheet. The required attachments are annexed to this order as Exhibit A, Exhibit B, and Exhibit C.

Counsel and pro se participants who have already registered (and been granted) Zoom access during the Title III Plan Confirmation Hearing **do not** need to file a Pretrial Informative Motion because the Court will automatically register these participants for Zoom access for the Title VI Hearing. A party-in-interest<sup>1</sup> who has not participated in the Title III Plan Confirmation Hearing but requests participation in the Title VI Hearing must file a Pretrial Informative Motion by **3:00 p.m. (Atlantic Standard Time) on November 19, 2021** to register for Zoom access in accordance with the Second Amended Confirmation Hearing Procedures Order ¶ 4(a). The party must annex the required Party Appearance Sheet, Witness Cover Sheet, and Exhibit Cover Sheet to the Pretrial Informative Motion. Any party who wishes to cross-examine any declarant/Remote Witness<sup>2</sup> or present testimony in connection with Title VI Hearing **must** file a Pretrial Informative Motion clearly indicating (1) the Remote Witness(es), (2) the factual issue(s) to which the proposed cross-examination or testimony relates, (3) the subject matter of the testimony and its relevance to the factual issue(s), and (4) the time

requested for such examination or testimony. A Pretrial Informative Motion shall be filed separately in each Title VI case to ensure the Exhibit Cover Sheet accurately reflects the docket entry numbers of the exhibits that were filed to the docket in that case.

**Title VI Hearing Agenda.** The second informative motion the Oversight Board shall file is a Title VI Hearing Agenda, which shall include: (a) the parties (including any persons appearing pro se) who intend to appear and speak, (b) the names of the attorneys who intend to speak on behalf of each party, (c) the order in which the parties will present argument, (d) time allocations for each speaker who will appear on November 22, 2021, (e) the names of any Remote Witness(es) that will be cross-examined, (f) the names and anticipated order of the parties who will cross-examine the Remote Witness(es), and (g) the name(s) of any party who anticipates conducting redirect examination of the Remote Witness(es). The Title VI Hearing Agenda that must be filed in each Title VI should be substantively identical.

2. Any party who intends to introduce exhibits at the Title VI Hearing shall file the exhibits in accordance with *Order Regarding Confirmation Hearing Exhibit Procedures*. (Docket Entry No. 18749 in Case No. 17-3283). A party shall file the exhibit list and exhibits to the appropriate docket corresponding to the Title VI case that the exhibits will be introduced. Importantly, the Exhibits **must be filed** before the Pretrial Informative Motion is filed because the Exhibit Cover Sheet requires the docket entry numbers corresponding to each exhibit.

3. Courtroom formalities shall be observed in accordance with Second Amended Confirmation Hearing Procedures Order ¶ 9.
